#### Cocoa NRCS Report to BSWCD

On September 23, 2024 NRCS and the Seminole SWCD held a program sign-up event in Geneva. Seminole SWCD sent +900 postcards to addresses in Brevard and Seminole county to promote attendance. The address list was generated from county property appraiser's records of parcels with agricultural tax classification. Approximately 30 people attended the event. NRCS presented on Conservation Programs that area available to ag producers. Farm Service Agency attended and presented on their programs, specifically disaster related funding.

Sign-ups for FY 2025 programs were batched on 11/1/2024. NRCS accepts applications 365 days a year so producers can continue to sign up for a possible  $2^{nd}$  batch.

72% of this year's applicants have never participated in NRCS programs.
